2.0 Reports:

- 2.1. Curriculum Reports Elementary Education and Preschool: Elementary faculty members (Cassidy Wallin, Meghan Flood, Erin Forre, Angel Gaspers, Emily Niewohner, Karla Patzel, Cristina Hanzel, Chelsea Kaufman and Shelley Dunlap) presented curriculum reports. The focus was primarily on the use and positive results from extra intervention implemented in the lower elementary grades.
- 2.2. Counselor's Report: Mr. Rudloff's report included information on senior careers, college preparation and 2018-2019 class registration. He also introduced his student teacher for the semester, Felicia Reed.
- 2.3. Activities Director's Report: Mrs. Patzel's report provided information on music events, speech contests, district wrestling, subdistrict basketball, and spring sports practice.

- 3.5. Approve NETA for Instructional Staff In-Service 2019. Passed on a motion by McCloud and second by Chilson. Vote: 6-0.
- 3.6. Approve 2018-2019 Academic School Year Calendar. Passed on a motion by Buhl-Jorgensen and second by Wallin. Vote: 6-0.
- 3.7. Approve Principal's Contract. Passed on a motion by Wallin and second by Nelson. Vote: 6-0.
- 3.8. Approve Superintendent Contract Amendment. Passed on a motion by Nelson and second by McCloud. Vote: 6-0.
