1.0 Call to Order

- 1.1. Roll Call: President Krueger called the meeting to order at 7:40 p.m. All members were present.

- 1.6. Public Comments: None

2.0 Reports:

- 2.1. Curriculum Reports CILT (Continuous Improvement Leadership Team) presentation by Erin Forre and Donna Miller. Mrs. Forre and Mrs. Miller have met monthly, along with Mr. Shalikow, Mr. Barnes, Mrs. Dunlap, Mrs. Amen, Mr. Rudloff and Mr. Wiemer to discuss, talk about and brainstorm ideas for our school. Their goal: "All students will increase their vocabulary across all academic areas which will assist students in improving their Nebraska State Assessment scores in Mathematics, Reading, Writing and Science". The CILT team presented to an external team on February 6, 2018, which went extremely well.
- 2.2. Counselor's Report: Mr. Rudloff's report included information on directing seniors in the process of filling out scholarships, writing recommendations, taking 8th and 9th grade students to NECC on two separate days for career day, and registering students for the NECC Scholastic Contest and Quiz Bowl to be held on March 21st.
- 2.3. Activities Director's Report: Mrs. Patzel's report provided information on music in our schools, a successful little kids wrestling season, and boys' basketball season update. Track and golf practice has begun. We have 5 high school and as many as 16 junior high track athletes participating this year, along with 2 golfers.
- 2.4. Principal's Report: Mr. Barnes reported on the success of our State FFA Qualifiers. 21 students from Newman Grove and Lindsay have qualified, along with 6 teams. Mr. Barnes also reported on "Dental Day in the Elementary", NSCAS testing to begin on March 20th and ACT on April 3rd, winter homecoming discussion as participation is low, and taking action on Random Drug Testing policy at the April Board Meeting.
- 2.5. Superintendent's Report: Mr. Shalikow reported on the NRCSA Spring Conference (March 22 & 23). Newman Grove Schools will be receiving "Closing the Achievement Gap" Award at the Spring Conference. Mrs. Forre and Mrs. Miller will be sharing things

we have done to "close the gap" Friday morning at 8am. Mr. Shalikow also discussed in detail the corrective plan update of a kitchen remodel due to fire marshal's findings and the status of what has been completed and what is pending on that report.
